Day 1: Foundations of Organisational Ethics Compliance in Projects

- Introduction to organisational ethics and compliance.
- Legal and regulatory frameworks: SAQA, King IV, and sector-specific codes.
- Ethical principles: integrity, transparency, accountability, fairness.
- Project governance structures and ethics committees.
- Ethical decision-making models and tools.
- Common ethical issues in projects: conflicts of interest, bribery, nepotism.
- Whistleblowing and reporting mechanisms.
- Practical steps to embed ethics in project planning and execution.
